SUBJECT: All States Log Number I01-0053 Publication of NGR (AR)
600-22/NGR (AF) 36-3 National Guard Military Discrimination Complaint system

1. On 30 March 2001, subject regulation was published for immediate implementation. The Army and Air National Guard will use this regulation to process all military discrimination complaints to include those currently filed and/or being processed prior to the effective date of this regulation. NGB-EO will publish the NGB Military Investigation Procedural Manual in the near future.
2. This regulation will be available on the National Guard Bureau web site by 1 April 2001. Hard copies can be obtained through normal distribution from the Maine printing plant.
3. It is recommended that the users review the publication and note additions/changes in the following procedures:
 - a. Paragraph 1-8. Time limits for processing complaints of discrimination have changed.
 - b. Paragraph 1-9. Time limits for AGR (Title 32) complaints processing (new).
 - c. Paragraph 2-1. Informal complaint procedures (new).
 - d. Paragraph 2-3. Acceptance, dismissal, and referral of complaints (new).
 - e. Paragraph 2-6. Allegations Against General Officers, General Officers Select, Colonels and Colonels Select (new).
 - f. Paragraph 3-1. Fact finding procedures (new).
 - g. Figure 1-1. NGB Form 335, Reprisal Complaint Advisement and Election Form, Page 9 (new).
