WHO MAY APPLY:

Must be a current member of the Illinois Army National Guard within the grade(s) of O3(P) and O4. This is a 3 year one time occasional tour (OTOT). On-board AGR's are open to apply and will remain as Career Status in the T32 AGR Program.

AREA OF CONSIDERATION: This position is open to the grades of: **O3 to O4**. Individual selected will receive an AGR tour with the Illinois Army National Guard. **In order to be considered for this position, applicants must meet minimum qualifications as outlined on this announcement.**

POSITION COMPATIBILITY REQUIREMENTS:

The individual must qualify for and be placed in the following compatible MOS/AOC: **01A**

MINIMUM APPOINTMENT REQUIREMENTS:

1. Applicants must meet initial eligibility requirements of Table 2-1, AR 135-18.
2. Applicants must satisfy requirements outlined in NGR 600-5, NGR 600-200, and NGR 601-1
3. Must meet the Army medical retention standards in accordance with AR 40-501, Chapter 3.
4. Must meet the Army body fat standards IAW AR 600-9.
5. Must be able to possess a SECRET clearance
6. Must have a current Army Physical Fitness Test taken within 12 months of the start date.
7. Selectee for Commissioned Officer positions must complete the specialty compatible with the position and become qualified in the appropriate Area of Concentration (AOC) within 12 months of assignment.
8. Selectee must be able to complete a 3 year tour of active duty prior to completing 18 years of active federal service, unless waived by NGB.
9. Applicants separated from military service for cause constitutes ineligibility, unless National Guard Bureau (NGB) grants an approved exception to policy/regulation prior to application submission
10. Applicants must have no derogatory information within their Official Military Personnel Record (OMPF)
11. Applicants must not be subject to flagging actions during selection or upon entering an AGR status.
12. No record of conviction by special or general courts-martial or civilian courts of offenses listed in AR 27-10 (Military Justice), chapter 24 or otherwise required to register as a sexual offender under AR 27-10, chapter 24.
13. Must not be a candidate for an elective office, hold a civil office, or are engaged in partisan political activities.

14. Selectee must be able to pass the Inspector General suitability screening.
 15. Selectee is required to complete the Department of the Army Inspector General - Basic course as well as the Secretary of the Air Force Inspector General qualification course.
 16. Assignment to this position is for a minimum period of three years.

BRIEF JOB DESCRIPTION:

Responsible for receiving, review and processing Inspector General Action Request (IGAR). Provide assistance for soldiers, families, civilian employees, and retirees. Provide the Adjutant General with a continuing objective assessment of the efficiency, discipline, esprit, readiness, and resource utilization. Teach and train soldiers, leaders, units and commands to improve operations and accomplish command objectives and standards. Monitors the efficiency of systems and processes within the Illinois National Guard in accordance with TAG priorities and philosophy. Assists/conduct investigations and inquiries as directed by TAG to include oversight of Army and Air Guard investigations and inquiries. Provide scheduling, coordination, reports, analysis and follow-ups for TAG's Command Readiness Inspection Program. Serves as TAG's proponent for all aspects of the inspection program. The Department of Military Affairs-IL (DMAIL) Inspector General serves as an independent and objective official responsible for conducting, supervising, monitoring and initiating audits and investigations relating to the programs and operations of the DMAIL. The Inspector General provides leadership and coordination and recommends policies for activities to promote economy, efficiency, and effectiveness in the administration of, and to prevent and detect fraud and abuse in, such programs and operations. The Inspector General is also responsible for keeping the Adjutant General fully and currently informed about problems and deficiencies relating to the administration of such programs and operations and the necessity for, and progress of, corrective action.
